Collective Series J Storm Drain Improvement Project

The Collective Storm Drainage Improvement Project (SDIP) Series J contains three separate projects with unique differences. The work involves various storm drainage improvements including replacement of storm drainage structures, water line, sewer line, asphalt pavement, concrete driveways, concrete sidewalk and curbs. Improvements will realign storm drainage to reduce structure flooding and address failing infrastructure. Due to the proximity of projects and their proximity to utility poles/structures/retaining walls, active shoring will be required.
